8. Any Other Business

a) Suspension of MNAs in arrears – Cary Lee Byerley

Cary Lee Byerley (Group O) asked the Board to review the Debtors list and to consider writing off debts for MNAs. The CEO confirmed that this is on the agenda for the next Board meeting on 14 December 2021.

b) EAWP – Jan Martin Wilschut

Jan Martin Wilschut requested an update regarding the EAWP and the appointment of Race Officials for the 2022 Youth Worlds, the 2023 World Championship and the Paris 2024 Olympics, including whether the Classes would be involved in appointments.

Tomasz Chamera explained that the appointments for the 2022 Youth Worlds have not yet commenced, and that appointments for the 2023 World Championship and the Paris 2024 Olympics was the top priority, with appointments expected to be announced shortly. Tomasz Chamera also confirmed that relevant Classes, and also the event organisers, were being engaged with regarding appointments and that this would continue.

c) Participation figures – Malav Shroff

Malav Shroff (Group K) asked whether action could be taken to ascertain participation numbers in the sport of sailing globally.

The CEO explained that the World Sailing Trust had carried out a participation survey, but that assistance with that work in future would be welcomed.

d) Ethics Commission cases – Wolfgang Mayrhofer

Wolfgang Mayrhofer (Group B) requested an update on ongoing cases before the Ethics Commission. This item of Any Other Business was unintentionally omitted from discussion during the meeting and the Interim Director of Legal & Governance provided an update to Council via email on 30 October 2021, the day after the meeting.

9. Next Meeting

Council noted that the 2022 Mid-Year Meeting would take place in Abu Dhabi between 24-27 March 2022.

Council noted closing remarks from the President.

There being no other business, the President closed the meeting.
