1. Opening of the Meeting

(a) Welcome from the Chairman

The Chair Ana Sanchez (AS) opened the meeting and welcomed the Committee members on their first meeting as a group within the new quadrennial, thanking them for the substantial work already over this year.

The Committee took a moment to remember those who have contributed to the progression of the Racing Rules of Sailing who have passed away during this year.

The Chair also welcomed Vice President Philip Baum (PB) responsible for Racing Rules who gave a brief update to the group from the Board on Finance and Governance.

The Chair noted the knock-on to the RRC workflow that were experienced due to the date adjustment of the Olympic Regatta including requirements for review and updates to areas concerning Rule 42, Addendum Q and others. New challenges lie close ahead with completion of a new rule book by June 2024, including a complete revision of Part 5, rule 18 and the equipment related rules in Part 4, as well as continued improvement to standardize the language and the structure of the appendices of the different

disciplines in the rule book. The Chair recognised this as a huge amount of work for all of the Committee and a great deal to move forward.

In addition, it was noted that high importance should be given to the identification of individuals around the world who can be future RRC members, to help guarantee a strong future in the management of this area. The Chair appealed to members to find a person to mentor and introduce to the processes of the Committee.

The Committee noted the report of the Working Party, and a short update was given on the presentation of rules online and the work on appendices for disciplines, slalom, expression, and speed etc.

An additional verbal report elaborated on the identification of issues around Rule 18 (to be picked up with the Rule 18 WP). Work also to progress with the Race Officials Committee on the current first draft of a manual for officiating medal race series which for Kites is different to Addendum Q.

The Chair reflected on the rejection of some 2021 submissions within this subject area, and with reference to current work which continues to be undertaken within this Working Party.

(n) Part 5 and related Appendices Working Party

The Committee received a brief report on new proposals for changes and reorganisation of Part 5 which are to be presented in principle for discussion to the Committee in the first half of 2022 for feedback.

(o) MNA Prescriptions Working Party

The Committee noted the report of this Working Party which is a new group for the term. Discussion was received on elements surrounding prescriptions requested which relate to Appendix N. It was agreed that the regulations and policy should be reviewed as an action through the Executive involving the Race Officials Committee and Constitution Committee

(b) **Equipment Committee/ Equipment Rules Sub-committee**

There were some delays in progression of activity due to the disruptions caused by COVID-19 and personnel across committees involved in the Tokyo 2020 rescheduled event for 2021. Work is expected to begin positively in the final quarter of the year with positive outlook for further collaboration moving forward into 2022 which is reflected in Agenda Item 8.

- 1) Rationalise rules relating to equipment and its use to ensure consistent definitions and interpretations and clearer lines of responsibility***
- 2) Study options to incorporate the ERS into the RRS***
- 3) Resolve conflicts between the RRS and ERS***
- 4) Advise the RRC on other submissions about rules involving equipment-related rules in the RRS***

The members of the joint working party shall be appointed jointly by the Chairmen of the Racing Rules Committee and Equipment Rules Sub-committee."

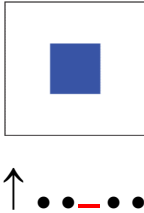

This “yellow paper” is a summary of the Decisions & Recommendations made at the Racing Rules Committee meeting on 26 October 2021.

024-21	Racing Rules of Sailing – Definition Gate Reporting Committee: Racing Rules Other Committee: Race Officials <u>Decision: Reject</u> The absence of a definition has not led to any problems that the Committee is aware of.
025-21	Racing Rules of Sailing – Race Signals AP/A, AP/H, N/A, N/H Reporting Committee: Racing Rules Other Committee: Race Officials <u>Decision: Reject</u> The new text proposed does not apply to all kinds of racing (for example, keelboats do not return to shore). It is inappropriate to add a rule into Race Signals.
026-21	Racing Rules of Sailing – Definition Finish Reporting Committee: Racing Rules Other Committee: Race Officials <u>Decision: Reject</u> A wider review of the issues arising from the new Definition Finish, Sail the Course and rule 28 needs to be undertaken. It is inappropriate to make an urgent rule change now.
027-21	Racing Rules of Sailing – Rule 32 Reporting Committee: Racing Rules Other Committee: Race Officials <u>Decision: Approve with amendment:</u> 32.2 <u>To shorten the course, the race committee shall display flag S with two sounds before the first boat crosses the finishing line. The two sounds shall be repeated as boats near the finishing line. If the course is shortened race committee signals a shortened course (displays flag S with two sounds), the finishing line shall be,</u> (a) at a rounding <i>mark</i>, between the <i>mark</i> and a staff displaying flag S; (b) a line the course requires boats to cross; or (c) at a gate, between the gate <i>marks</i>. The shortened course shall be signalled before the first boat crosses the finishing line. Shortened Course 

	S – Shortened course. Two sounds repeated as required by rule 32.2. S – The course has been shortened. Rule 32.2 is in effect.
028-21	Racing Rules of Sailing – Rule 44 Reporting Committee: Racing Rules Other Committee: Race Officials <i>Decision: Reject</i> More research amongst the community needs to be undertaken.
029-21	Racing Rules of Sailing – Rule 44.3 Reporting Committee: Racing Rules Other Committee: Race Officials <i>Decision: Approve with amendment:</i> Amend so that rule 44.3(a) starts with “If specified by the notice of race or sailing instructions,…”
030-21	Racing Rules of Sailing – Rule A10 - RAF Reporting Committee: Racing Rules Other Committee: Race Officials <i>Decision: Reject</i> This would create a third abbreviation for a boat not finishing (DNF, RET and RAF). The Committee supports reviewing the use of abbreviations overall.
031-21	Racing Rules of Sailing – New Case Reporting Committee: Racing Rules Other Committee: Race Officials <i>Decision: Reject</i>
033-21	Racing Rules of Sailing – New Case Reporting Committee: Racing Rules Other Committee: Race Officials <i>Decision: Approve</i>
035-21	Racing Rules of Sailing – Terminology Reporting Committee: Racing Rules Other Committee: Race Officials <i>Decision: Reject</i> The Committee supports the concept but the current proposal needs further work. In particular, the rules may need to accommodate conflicts between different languages which are not English.
