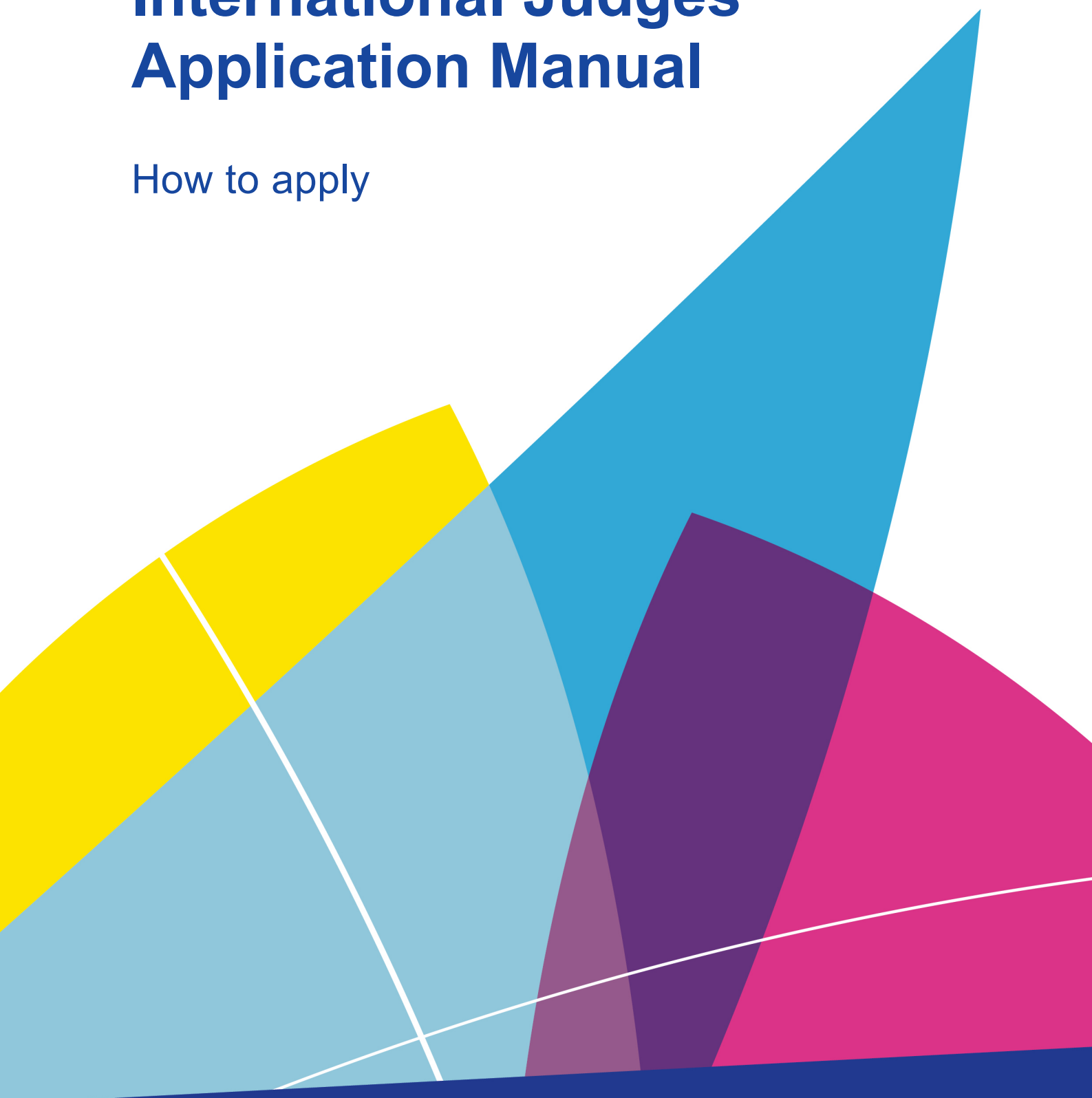

Registering for the Platform

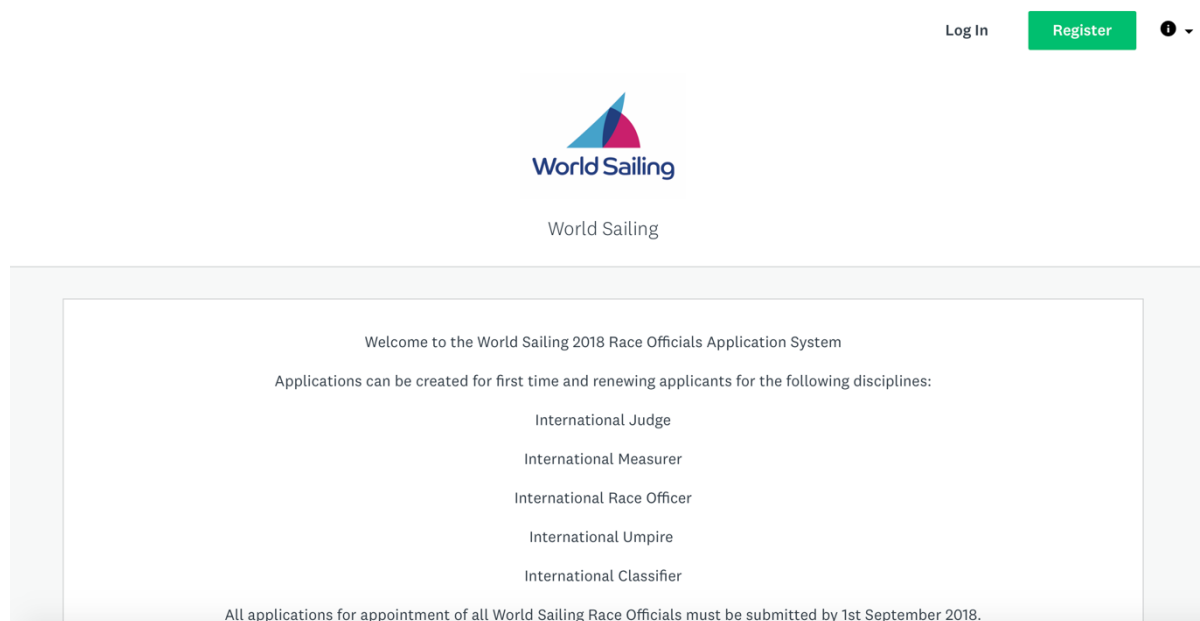
