31.14 If a candidate does not meet all the requirements for appointment, the following provisions shall apply:

31.14.1 If a candidate for first appointment due to **extenuating** circumstances, **which includes Covid-19 and the impact thereof**, does not meet **one or more** of the requirements **for appointment**, ~~for principal events~~, the Race Officials Committee may appoint the candidate for a full four-year term. **The candidate must comply with any specific requirements in the Race Officials Roles, Qualifications and Competences document relevant to the discipline of their**

application, except that Race Officials Committee may consider activities completed outside the normal designated period.

31.14.2 If a candidate for re-appointment due to **extenuating** circumstances, **which includes Covid-19 and the impact thereof**, does not meet **one or more of** the requirements **for appointment**, the Race Officials Committee may:

1. (a) re-appoint the candidate for a full four-year term; or
2. (b) extend the existing appointment for 12 months.

31.14.3 The Race Officials Committee may publish guidelines for the application of these exceptions, which may include applying them to groups of race officials.
