

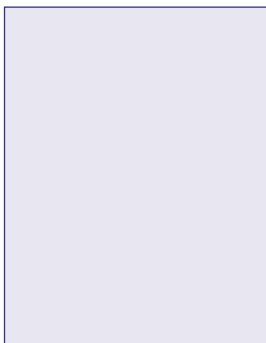

The chairs, vice-chairs, and members of Committees and Sub-committees will be appointed by Council on the recommendation of the Board in accordance with Article 50 of the 2024 Constitution. To be nominated, your application must be submitted to World Sailing on this form by an authorised nominating body (unless (e) below applies).

The authorised nominating bodies are

- (a) any Member National Authority may nominate persons to any Committee or Sub-committee;
- (b) any World Sailing Class Association may, with the written consent of a person's Member National Authority, nominate such persons to the: (i) Equipment Committee; (ii) Equipment Rules Sub-committee; (iii) Growth of Sailing Committee; (iv) International Measurers Sub-committee; (v) Oceanic & Offshore Committee; (vi) Para Sailing Committee; (vii) Regional Games Committee; and (viii) Youth Events Committee;
- (c) the World Sailing Classes Committee and any Commission may, with the written consent of a person's Member National Authority (MNA consent is not required for the EDI Committee), nominate such persons to any Committee or Sub-committee (provided that the nomination is agreed at a properly held meeting of the Committee or Commission);
- (d) any body which is specified in the Regulations for this purpose may, with the written consent of a person's Member National Authority, nominate such persons to the Specialist Sailing Committee; and
- (e) for the Equity, Diversity and Inclusion Committee, individuals may nominate themselves directly to World Sailing without the consent of their Member National Authority and World Sailing Classes may nominate without the consent of the Member National Authority
- (f) for the Specialist Sailing Committee anybody which has been granted World Sailing Special Event status may make a nomination without the consent of the nominees MNA (subject to pending Constitutional amendments).

Commissions are appointed by the World Sailing Board. You do not need to be nominated by another body and can submit your own application direct to World Sailing.

For Judicial positions Investigations Panel, Disciplinary Tribunal and Ombudsman, these are appointed by a separate process but individuals are welcome to indicate if they wish to be considered for appointment to these roles. You do not need to be nominated by another body and can submit your own expression of interest direct to World Sailing.

Under the New Constitution there are now limits on the terms of office for Members of a Committee or Sub-committee who may serve for up to four consecutive terms of office on a particular Committee or Sub-committee and, for the avoidance of doubt this includes terms of office served before and after the General Assembly in 2024.

However, Council may, on the recommendation of the Board, appoint a member for a fifth or additional term when the Board considers there are exceptional circumstances to do so and also note that a break or an appointment to a different body will reset the limit.

In accordance with the Regulations, all nominations must be received at the World Sailing Executive Office by 1 August 2024. There is no provision for extending this time limit.

The World Sailing Executive Office will acknowledge all nominations directly to the nominating body and the nominated candidate within 5 working days of receipt.
