

Classes Review Report

Introduction

In accordance with World Sailing Regulation 10.13, the Equipment Committee (EQ) conducts periodic reviews of World Sailing Class Associations every three years. These reviews are crucial for determining whether each class still meets the requirements outlined in Regulation 10.13.1 to maintain their World Sailing Class status. Failure to meet these criteria can lead to the reconsideration or withdrawal of the class's status, as per Regulation 10.13.2.

This report outlines the current status of several World Sailing Classes, based on the updated evaluation matrix and scoring system introduced in 2022. The goal is to ensure transparency, fairness, and accountability, while safeguarding the integrity of World Sailing and its associated classes.

Review Procedures

A Working Party (WP) formulated a strategy to review World Sailing Classes regularly, as required by Regulation 10.13. This includes making recommendations to the Equipment Committee for potential withdrawal of World Sailing Class status where classes fail to meet the set criteria.

To assess each class fairly, the WP employed a matrix and scoring system to rank classes for review. This approach ensures that selection for review is objective, based on measurable compliance issues. Data is primarily sourced from the annual reports submitted by each class by February 1st each year. In cases of incomplete information, the Office actively contacts the respective class to fill the gaps.

Evaluation Matrix and Compliance Scoring

Classes are evaluated and ranked based on total points, with different weights assigned for non-compliance. Points are allocated across several categories, such as global distribution, unpaid debts, incomplete annual reports, lack of technical representatives, and non-compliance with World Championship requirements. Detailed scoring criteria can be found in Appendix A of this report. Classes scoring seven or more points are subject to review with the intention of withdrawing their World Sailing Class status if issues are not resolved.

Upon identification, additional compliance information is compiled by the Office and shared with both the class and the Equipment Committee to promote transparency. The WP recommended, during the Mid-Year Meeting, that classes scoring seven or more points be reviewed and possibly have their status withdrawn if non-compliance persists.

Classes Working Towards Compliance

In addition to the classes under review or with withdrawn status, there are several classes actively working with World Sailing to address specific areas of non-compliance. The Equipment Committee recognises that some issues are complex and require extended efforts to resolve. As such, additional time has been granted to these classes, which are collaborating closely with WS and the legal department to meet the required standards.

The following classes are actively working towards compliance:

- Sunfish Class Association

- International Windsurfer Class Association
- SB20 Class Association

These classes are expected to resolve their outstanding issues by the deadlines set by WS, and their progress will be continuously monitored. World Sailing's approach reflects its commitment to fostering a supportive environment, ensuring that classes making genuine efforts are given a fair chance to comply.
