1 Opening of the Meeting

1.1 Welcome from Committee Chair

Jan Martin Wilschut welcomed Committee members and invited speakers and observers to the meeting.

1.2. Marcus Spillane, the Vice-President of World Sailing, extended a warm welcome to all meeting attendees on behalf of the board. He emphasized the pivotal role of classes in organizing sailors and events, expressing gratitude to committee members for their invaluable contributions to the sport's advancement. Spillane also provided an update on the board's progress regarding the Olympic vision, highlighting the dedicated effort and commitment invested in realizing these goals. Additionally, he expressed appreciation to Jan Martin for his extensive work engaging with classes over the past years, acknowledging the invaluable contributions of volunteers beyond the class structures.

1.3. The Committee members were invited to disclose any potential conflicts of interest that could impede the discussion or decisions on the agenda. No conflicts of interest were identified.

2 Minutes of the Previous Meeting

There were no matters arising that were not covered elsewhere on the agenda.

3 Committee Reports

The Committee activity reports were distributed before the meeting and are available as supporting documents on the World Sailing website. No questions or comments were received during the meeting.

4. Executive Office Report – from the Technical and Offshore Department.

Jaime Navarro thanked the classes for their cooperation in these challenging years. He introduced the team members. The team is also reviewing classes to identify those that do not comply with regulations. Looking ahead, the team strives to improve the service to classes, and part of the review will enable WS to focus resources on the classes that fulfill all the requirements. The office is looking at the possibility of allowing classes to hold a World Championship without being a WS class. The

office is also looking to provide rankings for all classes and develop engagement with offshore classes, including double-handed ones.

The Technical and Offshore executive report included an update on the following areas:

a) Classes Review Working Party – update

Pilar Lopez outlined the Working Party's role: to regularly review World Sailing Classes as per Regulation 10.13 and recommend withdrawals if needed.

In 2022, Byte Class and Farr 40 Class lost World Sailing status due to non-compliance found in their annual reports. Only 11 out of 118 classes met regulations, prompting reflection.

The Chair emphasized compliance for relevance. Despite proactive efforts, regulating 118 classes with limited staff remains a challenge.

b) Changes to the Builder's Licensing fee policy

Pilar mentioned the changes to the Builder's Licensing fee policy for builders licensed by World Sailing.

c) Plaques Report

Pilar presented the plaque report, emphasizing that in 2022, World Sailing sold a total of 7,861 plaques across 118 classes. Interestingly, only 6 classes contributed to 80% of plaque sales, while a broader range of 12 classes encompassed 90% of these sales. Notably, 46 classes reported no new equipment sales during this period.

d) In-House Certification Programme:

The In-House Certification report was distributed before the meeting and is available on the World Sailing website.

Francesco Gulizzi, World Sailing Technical Specialist, summarised the programme, remarking on the benefits to sailors of buying certified sails. WS runs the programme and trains the builders to ensure their sails are certified to the required standard.

e) Class Rules Change procedure

Francesco Gulizzi reported on the number of class rule changes received by the office and the corresponding approvals. Additionally, he provided a comprehensive summary of the current status of these changes.

f) WS partners and benefits for WS Classes

WS partners and the benefits offered to WS Classes were discussed.

g) Post-event Form

Pilar López elaborated on the purpose of the form, aiming to assist classes in adhering to regulations. Between January and September, there were 77 Class World Championships, out of which 50 classes successfully completed the necessary report, marking a 65% completion rate.

This process will aid the office in assessing the WS status of these classes.

5. Olympic Vision

Markus Schwendtner gives an update on the Olympic Vision. The information was circulated previous to the meeting.

7. Nominations to committees

There was a discussion about nominating individuals on behalf of the Classes Committee to other Committees for the upcoming year. There was a request for assistance from the legal department at the office regarding the formal process for submitting names. The deadline for submissions is set for August 1st.

8. Update on the Special Events Working Party

Marcus Spillane, Vice-President and Chair of the Working Party, of which Jan Martin is a member, updated the Committee on the progress made.

9. Keelboat Champion-of-Champions Event

Peter Hall raised the issue of the Keelboat Champion-of-Champions Event with David Graham. In 2018, there were plans to hold the championships with the Far East 28 in China. The format included a crew of 4, including a member from a different gender, and one Chinese participant per boat for a crew of 5. Ten boats were to be supplied for this event, scheduled for 3 or 4 weeks in November.

David informed the Committee that the proposed name for this event is the 'Champions of Champions Regatta', slated to be a Special Event in 2024.

10. Youth Olympics 2026

Alistair Fox provided an update on the current status of the organization for the Youth Olympics. It's confirmed that there will be windsurfers and possibly kitesurfers, but the selection of other equipment has not been finalized yet.

Hector Duval addressed the committee regarding the challenges faced in organizing the Sunfish World Championship due to issues with the builder, posing a threat to its international status. He appealed for support in maintaining this international standing.

David Sprague proposed establishing a Working Party (WP) to assist classes in enhancing their activities.

When faced with a decline in classes meeting regulatory requirements and reduced participation, it's crucial to contemplate the future. It's time for classes to form a WP to comprehensively assess the current status, regulations, programs, and data, emphasizing the need for thorough analysis and solutions.

The World Sailing Classes Committee (WSCC) recommends creating a WP to tackle participation decline and aid in activity development for struggling classes. Collecting data will be vital in analyzing participation and equipment status.

The Chair, on behalf of the Classes Committee, thanked Alistair Fox for his work over the past fifteen years and his collaboration with the classes, and wished him well in his future endeavours.
